The End-User acknowledges that use of SteadyTrader App must comply with the Apple Media Services Terms and Conditions, and that no usage terms provided herein override those rules.

2. Scope of License

The Licensed Application is licensed, not sold. Subject to this Agreement, MOR-TECH LLC grants the End-User a personal, limited, non-exclusive, non-transferable license to install and use SteadyTrader App only on Apple-branded devices owned or controlled by the End-User, and only as permitted under the App Store Usage Rules.

Use by multiple users through Family Sharing or volume purchasing is permitted if enabled by Apple.

3. Maintenance and Support

MOR-TECH LLC is solely responsible for providing maintenance, improvements, troubleshooting, and support for SteadyTrader App unless local law requires otherwise.

The End-User acknowledges and agrees that Apple has no obligation whatsoever to provide any maintenance or support services for the Licensed Application.

4. Warranty

If the Licensed Application fails to meet any applicable warranty, you may report the issue to Apple, and Apple may refund the purchase or subscription amount, if applicable. Beyond this refund, Apple has no other warranty responsibility.

To the fullest extent permitted by law, all warranty claims, correction of defects, and associated losses are the exclusive responsibility of MOR-TECH LLC.

5. Product Claims

The End-User agrees that MOR-TECH LLC, not Apple, is responsible for addressing any claims arising from the use or inability to use the application, including:
